

0: General Provisions

A: membership = membership

B: management = Disstrikt Models

C: talents = models, actors, influencers, content creators, and artists.

D: artists = photographers, dancers, singers, and musicians.

E: mandate = electronic bank signature.

1: Membership

A I: Disstrikt Models operates on a monthly membership basis.

A II: Disstrikt Models does not charge a registration fee.

A III: Disstrikt Models does not charge additional or hidden fees. This includes extra costs for additional photos, events, or a fee for casting.

B: Membership can be canceled monthly.

C: The notice period is 1 month.

D: Membership can be paused for up to 3 months. Any exceptions must be discussed with management.

E I: Pausing and/or canceling must go through your model coach via WhatsApp.

E II: Other scenarios, such as discussing/telling a model coach and other employees or unsubscribing via other channels/platforms (think of all social media accounts), are not considered legally valid.

F: The monthly membership is automatically debited at the end of each month on the 28th. The debit date can be adjusted; for this, you can contact your model coach.

G I: Upon registration with Disstrikt Models as a talent during the online audition, you always have the legal 14-day cooling-off period in which you can cancel your membership free of charge.

G II: The legal 14-day cooling-off period expires after 14 days and after attending a physical appointment.

2. Chargebacks

A: If you do not have enough balance in your account at the end of the month, your bank may have reversed the transaction. After receiving a chargeback, an administrative fine of €7.80 will be imposed.

A II: If you see before the 28th of the month that there is not enough balance in your account, you must inform your coach and can request a postponement.

B: If you have reversed the payment yourself, an administrative fine of €7.80 will be imposed.

C: If we do not receive any responses after 3 reminders, we will seek the assistance of a collection agency. Any additional costs will be calculated by the collection agency.

D I: If the model reverses one or more payments without any communication with the modeling agency, there will be a surcharge of up to 15% of the total amount.

D II: In case of late payment, the model will be in default without further notice of default and Disstrikt Model Management will claim the statutory interest on the outstanding balance, as well as the extrajudicial costs article 6.96 paragraph 2 sub b and c. These costs amount to at least 15% of the principal amount and include possible collection costs. The model explicitly acknowledges its liability for these costs.

3: Services

A: Active talents have access to all the services and benefits provided by Disstrikt Models.

B: The talent route consists of:

- model skill shoot
- portfolio shoot
- Job hunting 1
- Job hunting 2
- Job hunting 3
- Physical audition + test

C I: All active talents can get unlimited photoshoots in our studios. This can be without an appointment, on a walk-in basis with their own ideas and preparations.

C II: Unlimited means 1 shoot per day (365 shoots per year).

C III: The photos must be edited by the talents themselves.

C IV: Talents can use all the programs and software on the iMacs in the studios for editing. You can learn editing from your coach, the manual next to the iMacs, or ask for help from the model coaches present.

C V: Each shoot has a maximum duration of 30 minutes.

D I: All models, after passing the physical audition and testing, will receive a fully arranged foreign talent/model trip for one of the fixed brands (partners) of Disstrikt Models.

D II: Return tickets, transportation (in Spain), and accommodation in the Disstrikt villa will be fully covered for the model.

D III: Breakfast, lunch, and dinners are fully provided by the model coaches present in the villa in Spain.

D IV: The talent will receive a total of 3 photoshoots and a script during this trip.

Team-building outings will also be organized, including exploring the regions of Alicante and Valencia.

D V: The model can cancel the trip completely free of charge up to 30 days before departure.

D VI: If the model wants to cancel the trip within 30 days before departure, the model must cover 50% of the costs incurred. If the model cancels the trip within 14 days before departure, the model must reimburse 100% of the costs incurred.

D VII: The trip is only paid for the models. If the model wants to bring a friend or parent, this is allowed, but the extra person will not have the trip reimbursed and will have to cover the costs themselves.

D VIII: If the model is under 18 years old, at least one parent or guardian must accompany the trip. However, the costs for the extra person will still have to be paid out of pocket.

Disstrikt Models can offer a reduced price for the villa itself.

D IX: Disstrikt Models is not held liable for any damage or theft of personal belongings or any physical injury.

E: Active talents of Disstrikt Models can walk into one of our studios without an appointment, 7 days a week. Always check the current opening hours for this.

E II: Talents can use the content creation hub and all the equipment set up there (including cameras, stabilizers, and lights).

E III: Talents can also use the Macs set up in the studios, including all editing software. For questions, talents can ask for help from the model coaches present.

E IV: Talents can also always collaborate with other talents and artists in the studios to encourage making connections.

E V: Talents can also bring friends to the studios to, for example, take professional photos together and/or help create content and search for jobs.

E VI: Friends who are brought by the talents (and are not registered with Disstrikt Models) must purchase a day pass.

E VII: All talents can also search for work themselves in the studios through our platforms. Ask a model coach present to log into these platforms for you and get to work yourself!

4: Commissions & Payments

A I: Disstrikt Models does not ask for commissions until the talent has earned back their membership investment within the same month.

A II: After the talent has earned back their membership, a 25% commission will be applied.

A III: All talents receive a summary of all jobs and payments received by the agency at the end of the month, which is then transferred to the respective talents.

B: The talent has a duty to notify all jobs they find outside Disstrikt (however, no commission is applied to these).

C: The talent may not create their own accounts on the platforms used by Disstrikt Model to avoid double bookings. The current list can be requested from their personal agent.

5. Extra

A: All talents can cancel an activity on the route free of charge before 09:00 AM.

A II: If the talent or coach cancels after 09:00 AM, an additional payment of €10.00 will be charged for late cancellation.

B: The membership fee is for the studio service of Disstrikt Models, for providing all equipment, assistance from the coaches, and the use of the studios themselves.

C I: By registering, the model indicates that they are 18 years or older or have obtained permission from their parents/guardian and agrees to the general terms and conditions and GDPR agreements described by Stripe.

C II: The model must be 16 years or older according to Dutch law to sign a model contract. If the model is under 16 years old, the contract must be signed by a parent or other authorized person.

D: The model may register as a company in the trade register of the respective country. This allows the model to reclaim taxes on any costs incurred. Think of travel costs, the Disstrikt membership, and clothing for shoots! Your model coach will help you fill out your sales tax return every quarter.

E: The model enters into a subscription/membership with the modeling agency. The model knows how a subscription works and that it involves a monthly fee.

F: This is a non-exclusive contract. This means that after registering with Disstrikt Model Management, the model is still authorized to sign up with other modeling agencies, provided they also have a non-exclusive contract.

G I: Both parties wish to contract solely on the basis of an agreement of assignment within the meaning of article 7:400 et seq. BW.

G II: Both parties explicitly do not intend to enter into an employment agreement within the meaning of article 7:610 et seq. BW.

G III: This cooperation agreement is governed by Dutch law. Thus agreed and drawn up in duplicate and signed without coercion.

H: If the model cancels within less than 24 hours before the shoot, Disstrikt will not have to pay the amount to the coaches and other studio costs. If the model wants to reschedule this shoot, the model must pay €25. After this payment, the model can reschedule the shoot.

I: Refund of one or more amounts is not possible. If the model still has shoots or activities credit, this will be arranged by management within a quarter.

J I: Disstrikt Models is not liable for damage to property caused by third parties such as other models, photographers, and/or model coaches.

J II

: Disstrikt Models provides its professional photo and music studios, including its equipment. It is expected that models handle this equipment with care. If there is damage to the studio equipment, this must be reported to one of the coaches present, and a damage form will be drawn up detailing the compensation for the damage caused.

J III: To accurately determine which talent caused the damage, the cameras will always be reviewed.

J IV: If the damage is too high for the respective talent to pay, a payment plan will be drawn up together.

K: If the model shows commitment and motivation, the model can also take on the role of model coach. This allows the model to form a team of 10 own models and help these models grow. The model receives €165 per month from the modeling agency, which will be paid out every 14th of the month.
